

LanguageCert Academic – Test Format

Skill	Duration	Number of Items	Task Description
Listening	c. 40 mins	30 items	Test takers listen to a variety of academic situations, in a range of English-speaking accents, including explanations and instructions, lectures, conversations and discussions. Test takers identify gist, purpose, opinions and facts, specific information, cause and effect and answer 3-option multiple-choice questions and note- completion tasks.
Reading	50 mins	30 items	Test takers read a variety of academic style texts including discursive narratives, explanations, instructions, and articles. Test takers are assessed in understanding of academic vocabulary and lexico- grammatical features, textual structure and sequence, gist, development of ideas, intention, implied meaning, argument, opinion, attitude, summary, and synthesis. Test takers complete 3 and 4-option multiple-choice questions, multiple-matching tasks, and gap-filling.
Writing	50 mins	2 tasks	Test takers produce 2 pieces of extended academic style writing – report, argument, article, summary – in response to written, graphical or visual inputs. The writing should express attitude, opinion, and justification for a specific audience.
Speaking	c.14 mins	4 tasks	Test takers speak about themselves, their experiences, and opinions in academic context. They must initiate and take turns in a range of scenarios – reading aloud, answering questions, and presenting. (1:1 – interlocutor and test taker)

Test Security in Online Exams with Live Remote Proctoring (Invigilation) also known as 'OLP'

6-STEP CANDIDATE AUTOMATED ONBOARDING PROCESS

- 1. NDA & Terms of use agreement
- 2. Exam guidelines compliance
- 3. Face snapshot (for certain exams)
- 4. ID snapshot
- 5. Personal data verification
- 6. Exam Interface tutorial

6-STEP PROCTOR VERIFICATION PROCESS

- ID Check against registration data, ID document, and face snapshot
- Ensures candidate's location is quiet, with adequate lighting to see candidate's face & surroundings
- **3.** Requires candidate to rotate camera (360o) to show full room surroundings
- 4. Routine to prevent cheating (Clean desk, Bottle labels, Hidden mics & cameras)
- 5. Ensures candidate is always alone in the room
- 6. Validates exam session and admits candidate

NAVIGATION PREVENTION FEATURES

- Prevents right-click
- Prevents function keys
- Prevents important key combos
- Hides Taskbar and Desktop
- Hides menus and icons
- Prevents window minimization
- Prevents Copy/Paste
- Prevents printing

INFRINGEMENT PREVENTION FEATURES

- Terminates blacklisted applications, like screen capture and keyloggers
- Prevents launch of any application during the exam session
- Terminates all communication software
- Prevents execution on virtual machines
- Prevents simultaneous tests
- Allows one monitor, preventing display on others

Language

Exam Shield is an Application Lockdown system: Contrary to browser lockdown modules which control just a browser, PeopleCert's Lockdown system allows the user to perform only allowed actions across their PC /Laptop

PROCTOR ALERTS

System analyses A/V stream on-the-fly towards identifying notable behavior & system performance:


- Voice detection / Candidate Talking
- Candidate Tilting Head •
- Missing face •
- Multiple faces detected •
- **Background noises** •
- Battery and Internet connectivity performance

UNIVERSAL LOGS & AUDIT TRAIL

- All alerts are tagged, timestamped and logged so that they can be revisited during Audits
- All candidate and system actions are monitored, logged and bound to system and services performance providing a holistic view of every exam session
- All candidate actions and responses are saved in real time favoring robustness and resilience in case of any malfunction








